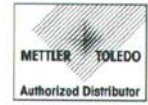

SERVICE PROGRAMS

Standard (Scale Test and Calibration Report)

Our standard small scale calibration service provides the customer with a simplified detailed calibration report for each weighing element tested. In this report you will find details including the calibration date and next calibration due date. We indicate if the scale was calibration test was performed at the customer site, or not. The technician responsible for the calibration test is shown along with their credentials. Scale system information is shown displaying all of the associated components by make, model, serial number and capacity. Scale performance is tested and documented as "Repeatability". Another verification of scale performance is determined by a "Shift Test" indicating the type of load cell system which dictates the test procedure to be used. Scale accuracy is documented using an incremental build up and down test showing "As Found" and "As Left" values including a 'Pass' or 'Fail' designation, you will see results of any span or linearity adjustments made. When applicable a "Strain Test" may be shown. Our policy is to perform all scale calibration tests to meet or exceed NIST Handbook 44 specifications, all processes can be found in our current QMS system. You will be provided with additional information pertaining to the current certification and traceability to our calibration weights used. In ALL cases each weighing system calibrated will have a 'Signed Approval Seal', otherwise known as a "Calibration" sticker applied showing the technicians name and credentials, day, month and year the calibration was completed and the 'Next Date Due' showing month and year.

Enhanced (ISO 17025 Calibration Certificate)

This is our most comprehensive calibration service. In addition to the Standard (Scale Test and Calibration Report) each weighing element is tested and calibrated with much more detail as follows;

- *Indicates 'Calibration Procedure Used' specific to our ISO17025 QMS system.
- *Documentation of the environment 'Temp: (F)' where the weighing element was tested and calibrated.
- *Designation of the weighing element 'Condition:' in generality.
- *Expanded 'Repeatability' findings.
- *Actual readings shown when the 'Shift Test' is performed.
- *More detailed 'Increasing/Decreasing' accuracy findings.
- *More detailed 'Strain Test' findings when applicable.
- *Detailed reporting of actual certified weights and devices used to complete the calibration and test.
